T. V. ALPHIN reserved early, swung five wide into the stretch and rallied under steady pressure. NO PASSAGE stalked the pace, moved four wide into the stretch and stayed on. GAGE PARK saved ground, remained inside for the stretch run and lodged a mild bid. MISTER SCOTT grabbed the lead, was headed leaving the turn and gave way. EASY TO GO never menaced. FABLE'S FINALE was off slowly and proved no factor. RIGGIN SLINGER showed little. LAUGH stumbled badly at the start, had his saddle slip and was eased.
