Footnotes

ELECTRIC BOAT, reserved in the opening stages while shifting nearer to the inside, continued unhurried between foes to the backstretch, shifted out nearing the far turn, commenced a steady four wide advance on the second bend, moved to wrest command in that path entering upper stretch and drew well clear under firm encouragement. LA PANCHITA settled outside foes in the last flight in the opening stages, came around rivals on the far turn, swung five wide racing into upper stretch and continued with interest to prove best of the others. POBRECITA bobbled at the start then bumped CAT HAS CLAWS, was quickly righted to press the pace between foes racing into the first turn, went clear entering the backstretch, dictated the pace off the inside into the second bend, couldn't match terms with the top pair but continued gamely to prevail for a share. NO ORDINARY COWGIRL tracked off the second flight outside foes racing to the backstretch, continued with a steady, three wide advance racing through the far turn to challenge for command between foes

entering upper stretch but lacked the needed final kick. ARRESTED BY DUFFY tracked the leaders three deep in the second flight in the opening half and continued evenly between foes in that path to late stages. SHE'S ABOVE DA LAW was guided to the inside early racing in the last flight while unhurried, shifted outside foes racing through the far turn, swung six wide in upper stretch and made an effort to improve position. AUTUMN GLORY, brushed by CAT HAS CLAWS at the start, was held up near the inside tracking off the second flight in the opening half and never gained contention. CAP'N SWIFTER, urged to secure a forward placing racing three deep between foes into the first turn, continued just off the leaders in that path through the backstretch, then steadily retreated racing through the far turn. CAT HAS CLAWS, bumped at the start while being forced into a rival's path, was righted to track between foes in the second flight, shifted to the rail nearing the second bend while being urged to lodge a brief bid but steadily faded entering upper stretch. MY BARBS tracked the leaders unhurried saving ground in the second flight racing to the backstretch and dropped out early. MIRACLE FOR TAY broke readily, was urged to gain terms with the first flight racing four wide into the first turn, continued between foes into the second bend while making a brief bid but gave way abruptly nearing upper stretch. MIDNIGHT KUGER, urged to dispute the pace inside foes racing into the backstretch, was spent after a half, was soon outdistanced racing into the stretch and walked off the course under her own power.
