INTIMIDATING WOMAN was settled well off the second flight outside foes in the opening stages, commenced a steady advance entering the bend, angled out four wide nearing upper stretch and continued with a solid late response to wrest command in time while holding NOT A LADY at bay under strong handling. The latter settled in last along the inside in the opening half, swung six wide racing into upper stretch and found her best stride to close the gap. BONEAFIDE CAT tracked the pacesetter outside a rival in the second flight racing into the bend, moved to wrest command in upper stretch while shifting to the inside and was collared late. LET IT RAIN settled outside foes in the opening stages, shifted out racing into upper stretch and improved her position four deep between foes. REFLATE THE BUBBLE sped clear of her foes while angling to the rail, dictated the into the turn and gave way near midstretch once headed. ANGEL COOKIE tracked off the second flight along the inside, angled out five wide to bid between foes racing into upper stretch but made no impression. MISTYMOON LAKE tracked the pace off the second flight between foes, angled to the inside entering the turn and lacked a rally. KITTY COVENANT, urged to secure a forward placing along the inside tracking the pacesetter, shifted out three wide racing through the turn while being urged to advance but quickly emptied out. DON'T DO THE CRIME dropped out of contention early. ALIBI GIRL was pulled up on the backstretch after the opening furlong and was vanned off the course.
