**Footnotes**

GUCCIONE pressed the pace, dug in for the stretch run and wore down his chief rival in the last sixteenth. FOXIE'S BOY gained the early lead, held well into the stretch, stayed on but was caught. BIG RUSHLET chased the pace while six wide, angled in for the stretch run and closed ground. HANGMAN reserved early, entered the stretch three wide and lodged a mild bid. IN NIKE'S HONOR passed tiring rivals. DEATH VALLEY was forwardly placed and dropped back in the stretch. DAKOTA REBEL proved no factor. ROCKET RODD showed little. DISTORTED GROOM saved ground early and weakened in the stretch.
