Footnotes

DIVA'S DIAMOND, caught four wide racing into the first turn while gaining position in the second flight, continued with a steady effort outside foes to challenge three deep racing into upper stretch and edged LOVE THY NEIGHBOR in the final stages under firm handling. The latter bobbed slightly, was then bumped at the start but was righted quickly while being urged to secure the lead along the inside racing to the backstretch, maintained a narrow advantage inside foes racing into the far turn, shifted off the rail entering upper stretch while continuing to dispute the issue with the winner, ducked inwards under pressure making contact with CALL ME CLASSY nearing the furlong marker and couldn't contain the winner in the final sixteenth. CALL ME CLASSY raced in close quarters between foes with maintaining striking distance as part of the second flight in the opening stages, was eased off the pace to track the leaders along the inside to the second bend, came through inside the pacesetter to challenge when presented an opening in upper stretch, was bumped and shuffled back leaving the furlong marker, but shifted outside the leaders in late stages to preserve a share. DIRECT BREEZE, off a step slowly, was settled off the second flight off the inside racing to the backstretch, then split foes three deep racing into the stretch in an effort to gain some position late. TEN LITTLE PINS, urged through close quarters in the opening stages to gain terms with the leaders along the rail, was eased back from that position nearing the backstretch while tracking off the second flight, swung out five wide racing into upper stretch but couldn't produce the needed closing response. COURTING DELILAH, in close attendance to the pace three between foes under light rating in the opening stages, continued in that fashion to the second bend but steadily faded after six furlongs. DUBIOUS settled in last near the inside racing to the backstretch and never gained striking position. FOLLOWING THE RACE THE STEWARDS CONDUCTED AN INQUIRY INTO THE STRETCH RUN AND THE RIDER OF CALL ME CLASSY LODGED A CLAIM OF FOUL AGAINST THE RIDER OF LOVE THY NEIGHBOR, ALLEGING INTERFERENCE. FOLLOWING A REVIEW OF THE STRETCH RUN THE STEWARDS DISQUALIFIED LOVE THY NEIGHBOR FOR INTERFERENCE, PLACING HER THIRD. THE TRAINER OF DIRECT BREEZE ALSO LODGED A CLAIM OF FOUL ALLEGING INTERFERENCE AT THE START WHICH WAS DISALLOWED.
