RACING BRAN chased along the inside, remained inside for the stretch run and rallied. BADGER BO reserved along the inside, angled off the rail for the stretch run and kept on. BISHOP CASEY saved ground, continued inside for the stretch run and lodged a mild bid. HOUSE OF USHER raced forwardly while three wide, entered the stretch four wide and had no finishing punch. DEPUTY SREVA passed tiring rivals. MY SONNY BOY outpaced while four wide, moved five wide into the stretch and managed no rally. A STEEL TRAP grabbed the lead, was headed leaving the far turn and gave way. GO TO THE SUN was always outrun. ECONOMIC BAILOUT showed little. OUGHTA BE MINE was settled while five wide and proved no factor.
