RICHIE'S HOT GIRL was urged to secure the lead along the inside soon after the start, gained a clear advantage racing into the bend, held sway into upper stretch and was kept to pressure to maintain a clear margin to the end. WRAPPED IN GOLD tracked off the second flight outside foes under some reserve in early stages, angled four wide while being urged to contention racing into upper stretch and secured place honors while closing the gap. COUNTRY CAUCUS, urged along five deep racing as part of the second flight in the opening quarter, moved to challenge three deep nearing upper stretch then finished evenly in late stages. SHE'S ABOVE DA LAW broke slowly, settled into stride near the inside, gradually gained contention while shifting out five wide leaving midstretch and made some belated progress. MY BARBS, bumped at the start, was a bit slow into stride, shifted outside foes racing into the stretch but never gained contention. ONE WINK tracked the pacesetter inside foes in second flight while taking a few erratic steps near the five furlong marker, was urged to briefly challenge racing through the turn but emptied out nearing midstretch. MISS PALATINE tracked the pace between foes in second flight in the opening stages but steadily faded nearing upper stretch. KITTY COVENANT broke outwards bumping MY BARBS at the start, worked her way to the inside tracking off the second flight racing into the turn but emptied out abruptly in upper stretch.
