WILD TALE saved ground near the middle of the field, came out four wide for the drive and rallied for a late decision. MR BIG TIME raced close up three wide and put a head in front in the stretch but could not hold off the winner. PUNCH BAG lacked speed off the rail and rallied belatedly for a share. CALL ROY had his rider lose the irons at the start then rallied belatedly. JACK OF MY HEART lacked speed and improved his position. TIMELY ENDING raced close up inside and tired. CASANOVA SLAMMER raced between horses and tired. ASAILORTOREMBLER set the pace from off the rail while pressed and also tired. MATTHEW'S BLESSING raced four wide and gave way.
