HOUSE OF USHER stumbled at the start, quickly recovered, was forwardly placed, moved four wide into the stretch, finished determinedly and was up in the final stride. WIN ME OVER chased the pace, gained a narrow lead up the backstretch, kept on willingly in the stretch but was caught. BILL OF BILLS settled while four wide, moved five wide into the stretch, loomed but hung. P D Q KIDDO controlled the early pace, dueled up the backstretch and was outfinished in the stretch. BEST BUDDY was outpaced while five wide and lacked a rally. BATTEN reserved while four wide, moved five wide into the stretch and offered no response. MARE'S EX never menaced. TOM ARCHDEACON went to his knees at the start and failed to recover.
