QUITE ACCEPTABLE lacked speed inside, was angling out in the stretch when carried wider, rallied and was along in time. KING OF THE WIND set the pace inside on a clear lead, came out from a left handed whip in the stretch and could not last. BOAZ stalked the pace off the rail, was bothered in the stretch and lacked a winning bid. MOVE ASIDE raced close up inside, angled out and was bothered in the stretch and weakened. CALLAHAN raced near the middle of the field and lacked a rally. ROMANTIC CAT lacked speed and was not a factor. HOPETOWN HERO raced outside and gave way. HERE B DEHALO was always outrun. COMIC KING gave way in the drive. THERE WAS A STEWARDS' INQUIRY INTO THE STRETCH RUN AND A CLAIM OF FOUL BY THE TRAINER OF MOVE ASIDE AGAINST QUITE ACCEPTABLE BUT NO ACTION WAS TAKEN.
