RULEROUS stalked the pace, forged clear around the far turn and held sway in the stretch. MANZANA reserved early, entered the stretch four wide and stayed on. ANIMO ONE awkward at the start, outpaced early, swung five wide into the stretch and managed a mild bid. PATH OF HONOR raced in striking position while four wide, remained four wide into the stretch and had no rally. MCCHARLES set a pressured pace, was headed around the far turn and yielded. TRUTH OF THE IRISH had his shoe fixed in the paddock and never menaced. THIEF ON THE CROSS showed little. RULERS EXPRESS chased the pace while five wide and dropped back around the far turn.
