BREEZE displayed mild late interest. QUEENLASEFA stalked the pace, led into the stretch and was worn down late. ROOVILLE was always outrun. CHARMING BAY raced in striking position while three wide and faded. INDIGO ICE grabbed the lead, was headed on the turn and gave way. TAP CITY was bumped at the start and never a factor.
