Footnotes

THERE GOES BEAU BO gained terms with a rival on the pace along the inside, attended the tempo racing into the bend, was urged clear in upper stretch and drew away through the lane while being kept to the task. LO ME tracked inside foes in the second flight racing into the turn and continued willingly between foes to late stages to prevail for place honors. CANDY VAN CAN tracked the pace unhurried along the rail from behind the second flight, saved ground to upper stretch, shifted out racing through the lane and continued well enough to earn a share. RUNFORGLORY broke sharply, forced the pace outside a rival racing into the bend, shifted inwards while losing terms with the winner and weakened in midstretch. CATHYS BREEZE settled a bit off the inside in the opening stages and improved his position near the inside racing into the stretch. U STEP ASIDE tracked the leaders four wide between foes in second flight racing to the turn and steadily faded nearing upper stretch. I'D MARRY ME tracked the pace between foes in second flight and gave way after a half. GATE PRANCER settled off the inside early and never gained contention. GRACIE'S HOPE was a brief factor five wide in the second flight but dropped out nearing upper stretch. DANCING SWORD settled off the inside early and never seriously menaced. THOR'S SWORD broke awkwardly, ducked inwards near the five furlongs marker while going erratically and lost his rider.
