ASYOUWISH raced four wide near the middle of the field and rallied in the stretch but could not finish with the winner. CANYONS SISTER vied for the lead inside but could not go with the top two. TUFTED saved ground and lacked a rally. LAHAR raced near the middle of the field and lacked a rally. I'VE BEEN HUMBLLED raced close up three wide and gave way. JENNIE R. lacked speed off the rail and passed tired ones. WOODLAND SPRITE was always outrun. SEATTLE LAKE raced off the rail and dropped back steadily. DAYTIME PLEASURE contested the pace from off the rail and gave way.
