HEARTBUSTER, rated off the pace, angled in to split rivals leaving the turn, angled back outside the leaders and rallied to be just up at the wire. THUNDER WONDER chased the pace, slipped through at the top of the stretch to take over command and just failed to last. BLAZING C. E. O. unhurried after stumbling at the start, rallied gamely along the inside in the drive. WEDGEFIELD, settled off the pace, steadied at the top of the stretch when HEARTBUSTER angled in and failed to rally. MARY LOU'S MAGIC dueled for the lead racing off the rail and tired. TRICKED AGAIN chased the pace four wide and faltered. MIAMI BREEZES was no factor. RILEY'S HEAT dueled for the lead three wide and faded. RUN FOR GLORY (VEN) showed little. PHONE SIGNAL pulled up on the turn and returned sore. The rider of WEDGEFIELD lodged an objection against the rider of HEARTBUSTER for alleged interference at the top of the stretch. The claim of foul was not allowed.
