**Footnotes**

DELL PLACE settled off the rail, came out leaving the second turn and five wide into the stretch, drifted in some in midstretch but rallied under good handling to prove best. ANZARI (IRE) unhurried inside early, came a bit off the rail on the second turn, waited momentarily then split rivals in midstretch, angled in off heels in deep stretch and finished well. SIGINT saved ground chasing the pace, came out leaving the second turn and three deep into the stretch, bid between horses in the drive, was bumped late and finished even for third. TOP HONOURS had good early speed and dueled inside, inched away leaving the second turn, drifted out late and bumped SIGINT in deep stretch. SPEED OF LIGHT (IRE) saved ground off the pace, inched forward on the second turn, swung four wide into the stretch, was in tight in midstretch and could not offer the needed late kick. HAWKEYE (IRE) off a bit slowly, angled in outside a rival early, found the fence on the second turn and did not rally. SAVAGE (BRZ) prompted the pace three deep for nearly six furlongs, was between horses in midstretch and weakened. TRIAL BY JURY vied for command between horses until leaving the second turn and also weakened. Following a stewards' inquiry, TOP HONOURS was disqualified from a share of third and placed fourth for interference in deep stretch.
