Footnotes

AMAZOMBIE broke in a bit, had speed between horses then set the pace a bit off the rail, angled in on the turn, kicked clear in the stretch and proved best under some left handed urging. QUICK ENOUGH close up stalking the pace inside, came out in upper stretch and was second best. MOBILIZED a bit slow to begin, settled off the pace while saving ground, moved up inside in the stretch and gained the show. SCOFIELD BARRACKS settled a bit off the rail on the backstretch and turn, came out into the stretch and was edged for third. LEGAL SEPARATION angled in and stalked outside a rival, was in a bit tight into the turn, came three deep into the stretch and was outfinished for a minor award. LEAVING NEW YORK pulled early, angled in and stalked inside, came out around a rival into the stretch and could not offer the necessary response. SANGER SILVER had speed three deep then stalked outside a rival to the stretch and weakened some in the drive. VADERTORE stalked off the rail or outside, continued alongside a rival into the stretch and also weakened. NIKKI'SGOLDENSTEED broke a bit slowly and was squeezed some, settled outside, went three deep on the turn and into the stretch and did not rally. BESTDRESSED between foes early, settled off the rail, came out in the stretch and was not a threat. AUTISM AWARENESS settled off the rail on the

backstretch, dropped back some into the turn and gave way.
