Footnotes

MY MAN SUMO stalked off the rail on the backstretch, bid alongside a rival on the turn and into the stretch, gained the advantage three deep in midstretch, inched away momentarily then held on gamely under urging between foes. FLASHMANS PAPERS (GB) angled in and stalked inside, came out a bit in the stretch, bid between horses in midstretch and continued willingly along the fence. JUSTICE REIGNS broke in a bit, raced between horses early, chased outside, came three deep into the stretch and finished well alongside the top pair on the line. DEE DEE'S LEGACY chased between horses or outside a rival, continued off the rail on the turn, came out in the stretch and lacked the needed rally. BEYOND LOADED angled in and stalked outside a rival on the

backstretch and turn, came out some in the stretch and could not offer the necessary late kick. A LIL DUMAANI sped between horses to the early lead, angled in and set the pace inside, dueled along the rail on the turn, fought back in midstretch but weakened in the final furlong. STAND TALL steadied when crowded at the start, went up three deep between horses on the backstretch, angled in a bit off the rail on the turn, found the inside in the stretch and did not rally. ISLAND RUN saved ground chasing the pace, came off the fence in the stretch and lacked the necessary response. BRINSON wide early, settled four wide on the backstretch, continued outside on the turn and a bit wide into the stretch and was not a threat. WHIZER between horses early, settled just off the rail, angled in on the turn, came out into the stretch and lacked a further response.
