Footnotes

TWOATTEN TENATTWO broke a bit slowly, chased inside, came out leaving the turn and three deep into the stretch, rallied to the lead under a left handed crack of the whip and an energetic hand ride a sixteenth out and proved best. CLUE ME IN chased off the rail, split horses on the turn, came out in midstretch and gained the place late. BLINGBOY had good early speed and dueled inside, inched away into the stretch, battled along the rail past midstretch and bested the others. IMAGE AND LIKENESS broke though the gate before the start, dueled outside a rival on the backstretch and turn and weakened in the stretch. ROMAN COUNSEL was in a good position stalking the pace three deep then outside on the turn and into the stretch and also weakened. STARCATTER allowed to settle off the rail, continued outside a rival leaving the turn and into the stretch and did not rally. BIG BAD BOO chased outside a rival, went three deep leaving the turn and into the stretch, drifted inward in the drive and lacked a further response. LEON AYALA stalked between horses, dropped back between foes on the turn, angled to the inside nearing the stretch and weakened.
