Non-winners of \$100,000 at a mile or over allowed 2 lbs.; such a race of \$50,000 allowed 4 lbs.; non-winners of two races other than claiming orstarter at a mile or over allowed 6 lbs.; such a race allowed 8 lbs. Nominations closed May 7 with 15. One supplement, Makeup Artist. Rail 15 feet.

**Footnotes**

MAKEUP ARTIST pulled her way along outside a rival chasing the early pace, went four wide on the second turn, continued three deep leaving that bend and into the stretch, gained a short lead past the eighth pole and proved best under some urging. RUTTERS RENEGADE (IRE) off a bit slowly, saved ground off the pace, swung out into the stretch and picked up the place late. SHAPES AND SHADOWS stalked the leader a bit off the rail, bid alongside that one leaving the backstretch and on the second turn, put a head in front into the stretch, fought back inside the winner in midstretch, could not match that one and was edged late for second. MAJOR IDEA stalked the pace outside a foe, was in a bit tight between horses into the second turn, steadied between rivals leaving that bend and could not offer the necessary late response. LITTLE MALVERN (GB) saved ground stalking the leader, was in a bit tight into the second turn, waited some leaving that bend, came out off heels in deep stretch and also lacked the needed rally. BARTOK'S BEAU sped to the early lead, angled in on the first turn, set a pressured pace inside, fought back along the rail on the second turn and into the stretch but weakened in the final furlong. DEJA tracked the leader outside a rival, went three deep between foes into the second turn, dropped back on that turn and weakened. A claim of foul by the rider of MAJOR IDEA against the winner for alleged interference on the second turn was not allowed by the stewards, who ruled the videotape failed to substantiate the claim.
