STRATHAM (IRE) pulled early, raced close up stalking the pace inside, bid along the rail in the stretch, gained a short advantage past midstretch and held gamely under urging. NEW JOYSEY JEFF stalked the pace inside then a bit off the rail, bid outside the pacesetter under urging then put a head in front three deep in midstretch, had the rider lose the whip past the sixteenth pole and could not quite match the winner late. OBRIGADO (FR) allowed to settle inside, continued along the rail in the stretch and gained the show. COREY COUNTY brushed the gate at the start, settled a bit off the rail, came out three deep on the second turn and into the stretch and was outfinished. NIAGARA CAUSEWAY chased outside a rival then between foes leaving the second turn, came out some in the stretch and lacked the needed rally. CORAZONDELCAPEON pulled his way to the early lead, angled in on the first turn, set the pace inside, battled between horses in midstretch and weakened in the final furlong. SILVER CREST (GB) pulled early, stalked outside a rival to the stretch and also weakened.
