Footnotes

TITIAN stalked between horses then a bit off the rail, came three deep into the stretch, gained the lead outside a rival nearing the sixteenth pole under left handed urging and won clear. CRISPY COREY chased outside on the backstretch and turn, came four wide into the stretch and just got the place. DETECTIVE POIROT had speed between horses then dueled outside a rival, inched away into the stretch, could not match the winner in the final sixteenth and just lost second. IGNITED also had speed between horses then dueled a bit off the rail, angled in leaving the backstretch, fought back inside on the turn but weakened in the stretch. HOTSTEPPER broke a bit slowly, chased between horses then angled in on the backstretch, went outside a rival on the turn and into the stretch and did not rally. TRIBUNAL BLUES settled off the rail then outside, went three deep into the turn and four wide into the stretch and could not offer the necessary response. PERSONALITARY four wide early, angled in and stalked outside a rival, came three deep into the stretch and

weakened. ROSIE AGREED broke slowly, settled off the pace inside, swung out into the stretch and was not a threat. TUBA MAN chased a bit off the rail, steadied between horses into the turn, came out three deep into the stretch and did not rally. BIG MAN IN TOWN pulled his way along to stalk the pace inside, was shuffled back into the turn and gave way in the stretch.
