QUIETLY MINE settled a bit off the rail then inside, moved up along the fence in the stretch and rallied under urging to gain the lead in deep stretch to prove best. EL SCORPIO chased a bit off the rail then inside, came out in the stretch and went past the pacesetter late for the place. CALL ME HONCHO a bit slow to begin, saved ground off the pace, moved up into the stretch and gained the show along the rail. SEA OF PLEASURE sped to the early lead, angled in and set the pace a bit off the rail on a clear lead, opened up on the turn, shortened stride in deep stretch and was overtaken between foes. BEYOND LOADED chased between horses, drifted out leaving the backstretch, angled in outside a rival leaving the turn and lacked the needed late kick. WITHIN REASON chased inside then a bit off the rail on the turn, went around rival into the stretch, came out in midstretch and could not summon the necessary response. BONFANTE chased outside or off the rail, came four wide into the stretch and did not rally. BEAUTEOUS MAXIMUS wide early, chased four wide then three deep, angled in outside a rival on the turn and could not offer the necessary rally. SHARK CITY stalked outside or off the rail, came three deep

into the stretch and weakened. FIRE IN THE WIND a bit slow to begin, pulled between horses and steadied a half mile out, fell back off the rail on the turn, came out into the stretch and was not a threat.
