CALLER ONE sped to the early lead and dueled outside ARCHER CITY SLEW, shook loose nearing the turn, drew off in the stretch and held sway under steady handling. DIXIE UNION stalked the pace between horses early then just off the rail, went outside a rival into the turn, closed the gap on the winner some late but was second best. SWEPT OVERBOARD was in a good striking position three deep early then off the rail, came out three deep into the stretch and lacked the necessary late response. ARCHER CITY SLEW went up inside the winner to press the early pace, stalked along the rail into and on the turn and weakened in the stretch.
