Footnotes

SCOOPS EXPRESS stalked outside then alongside a rival on the turn, came out into the stretch and rallied under left handed urging to be along in time. DELAWARE DOE dueled three deep then outside a rival leaving the turn, inched clear into the stretch, could not hold off the winner but saved the place. DEFENSE KING chased outside then alongside a rival, angled out into the stretch and picked up the show. TAVERN settled outside then three deep on the backstretch, angled in outside a rival on the turn, swung out into the stretch and lacked the needed late kick. DEFYING LOGIC had good early speed and dueled inside, fought back on the turn but weakened in the stretch. JACK FLASH settled between horses then off the rail, angled in on the backstretch, steadied off heels into the turn, came out into the stretch and could not offer the necessary response. J B WINE allowed to settle off the pace between horses then outside a rival, came four wide into the stretch and was not a threat. LET'SPICKUPTHEPACE sent between horses to duel for the lead, stalked just off the rail leaving the turn and weakened in the stretch. ALWAYS TRYING between rivals early, chased off the rail then angled in on the backstretch and lacked a response in the stretch. CAPT. PIKE had speed between horses then took back and angled in, stalked the pace inside, steadied sharply off heels into the stretch and weakened. HITTIN THE JACKPOT broke a bit slowly, settled outside chasing the pace, came three deep into the stretch and also weakened.
