CHATI VALLEY pulled some between foes early, chased a bit off the rail, came out on the second turn and four wide into the stretch, gained the lead past the eighth pole, kicked clear and held under left handed urging. I CAN SEE angled in and settled off the pace inside, came out into the stretch, split rivals in midstretch and closed gamely outside. LATE DATE stalked inside, came a bit off the rail for room on the second turn, split rivals leaving that turn and picked up the show. CHULLA ISABELLA three deep early, settled outside a rival, came out into the stretch and had a mild late bid. MALLEY GIRL sped to the early lead, set the pace inside, held on well until past midstretch and weakened late. MORE ANGELS chased outside a rival, went three deep between foes on the second turn, angled in nearing the stretch and weakened some. ANDOVER THE CASH pulled her way along inside and steadied into the first turn, came off the rail into the backstretch, went between horses into and on the second turn and lacked the needed rally. ASK KATHY chased outside, went four wide on the second turn and three deep into the stretch and weakened. DELMITA stalked outside a rival then between horses, continued a bit off the rail leaving the backstretch, angled in on the second turn and also weakened. FLOWER HILL pulled early, clipped heels into the first turn and lost the rider. The stewards conducted an inquiry into the run to the first turn but made no change when they ruled the videotape was inconclusive.
