DEE DEE'S LEGACY chased a bit off the rail, split horses nearing midstretch, gained the lead inside a sixteenth out, drifted out under left handed urging and held gamely. FIRE IN THE WIND prompted the pace three deep, stalked off the rail then outside the winner leaving the turn, re-bid three wide past the eighth pole, was floated out some in the final stages and continued willingly. SMOKENOMORE broke out a bit, had good early speed and dueled between horses then outside a rival on the turn, inched away approaching midstretch, fought back between foes a sixteenth out and bested the others. SOGNATORE (FR) allowed to settle off the rail or outside a rival to the stretch, came out some in the drive and did not rally. SHARK CITY dueled inside, fought back on the turn and into the stretch and weakened in the final furlong. RABBITPEAK unhurried along the inside on the backstretch and turn, had a rail trip and failed to menace.
