MENSA HEAT bobbled at the start, stalked the pace outside a rival down the backstretch, remained off the rail around the turn, angled to the wood into the stretch, took over the lead and drew clear in the final furlong. CAUGHT A FLYER sped to the early lead out of the chute, remained just off the wood down the backstretch and around the turn, gave up command in the lane and weakened some in the final furlong while a clear second. KILKENNY (NZ) chased on the outside to the stretch and did not mount the necessary rally in the stretch drive. SANQUINE was hustled to gain position out of the chute, stalked inside the winner down the backstretch, saved ground around the turn, was asked for his best nearing the quarter pole and did not respond in the drive. WALLEYE JOE chased a bit off the rail down the backstretch, remained on the wood through the lane and did offer a threat.
