DAYLIGHT STORM sped to the early lead outside, set the pace off the rail, angled in on the turn and won clear under some urging. SAMMY'S A RUNNIN' four wide early, chased outside then three deep on the turn, continued off the rail into the stretch and was second best. CAT ALLOWAY a bit slow to begin, was sent along inside, came out on the turn and four wide into the stretch and picked up the show. ACTION CALL sent between horses then stalked a bit off the rail, angled in on the turn, had the rider lose the whip past the quarter pole, came out into the stretch and weakened late. PHABULOUS PHIL stalked three deep then outside a rival into and on the turn, came out a bit into the stretch and also weakened. DANDY DANCER chased between horses then outside a rival, split foes into the turn, came out into the stretch, drifted to the inside in the lane and did not rally. SUITCASE SIMPSON four wide early, chased off the rail, went three deep into the turn and did not rally. WARRENS TEMPTATION settled between horses, was shuffled back in a bit tight into the turn, angled in, came out into the stretch and did not rally. GOLDEN BOY MARK was in a good position stalking the pace inside, dropped back on the turn, had the rider lose the whip in upper stretch and weakened. MY ROYAL CAT broke a bit slowly, settled between foes then a bit off the rail, split rivals into the turn, came out into the stretch and was not a threat.
