CAVANAUGH had good early speed and dueled off the rail then inside, responded when challenged again in the stretch and inched clear under urging. TOPPLER hopped at the start, went up inside to stalk the pace, split rivals into the stretch, bid outside the winner but could not match that one late. KERZNER stalked between horses then outside a rival leaving the turn, came four wide into the stretch and bested the others. OLYMPIC STRIPES chased a bit off the rail then inside, remained on the rail in the stretch and lacked the needed rally. TRI CITY DAN stalked between foes then a bit off the rail, came out leaving the turn and four wide into the stretch and lacked the necessary late kick. WARREN'S BLVD. dueled outside the winner, came three deep into the stretch and weakened. PRINCE MUMTAZ chased outside then off the rail, came a bit wide into the stretch and did not rally. PEEKA BUDDHA stalked four wide then three deep leaving the backstretch and into the turn, fell back some leaving the turn, angled in outside a rival into the stretch and weakened. BLAZENHEART broke slowly and saved ground, was in a bit tight a half mile out, remained inside and failed to menace. WILBUR CODWEN hesitated then walked out of the gate to be away behind the field, settled off the rail and was always outrun.
