SKIPTON CREEK pulled her way along inside to force the pace then came off the rail on the first turn and stalked outside a rival, bid alongside the pacesetter on the backstretch, had that one slip away a bit on the second turn, bid again outside that foe in the stretch, gained a slim lead under urging in deep stretch and held gamely between foes. ROSEHILL DEW (IRE) broke slowly, angled in and settled outside a rival, was in a bit tight between horses into the second turn, waited off heels into the stretch then split foes, came in and bumped WARREN'S FLYER in midstretch, angled out in deep stretch and closed willingly three deep on the line. ARTUYA tugged her way to the front a bit wide into the first turn, angled in and set the pace a bit off the rail, inched away inside on the second turn, fought back along the rail in the stretch and continued willingly to the wire. TRUE WAY OF GRACE pulled early and was in a bit tight off heels into the first turn, stalked inside, came out in upper stretch and could not quite summon the necessary late kick. LEMON DROP RIDGE was in a good position stalking the pace outside a rival then between foes on the backstretch and second turn and lacked the needed rally. WARREN'S FLYER saved ground chasing the pace, continued inside into the stretch, was bumped and steadied in midstretch and did not rally. HOUT BAY stalked three deep then four wide into the second turn, continued three wide on that turn and into the stretch and weakened. The stewards conducted an inquiry into the stretch run but made no change when they ruled the trouble to WARREN'S FLYER did not cost that runner an opportunity at a better placing.
