**Footnotes**

UNFURL THE FLAG sped to the early lead outside then dueled outside a rival, took command into the stretch and drew clear under some urging. BEAR IN THE WOODS unhurried off the rail on the backstretch, moved up outside on the turn and four wide into the stretch and rallied for a share of second. MCCANN'S MOJAVE close up stalking the pace three deep to the stretch, could not match the winner but held for a share of the place. SAINT AFLEET well placed stalking the pace between horses on the backstretch and turn, continued a bit off the rail into the stretch and lacked the needed response. HARVARD AVENUE angled in and saved ground off the pace, came out on the turn and four wide into the stretch and found his best stride late.

AREYOUTALKINTOME chased between horses then outside, came three deep into the stretch and did not rally. MASS MEDIA chased between horses on the backstretch and into the turn, continued a bit off the rail on the bend and lacked the necessary response. TASTE OF PARADISE also chased between horses then just off the inside on the turn and did not rally. TSIGANE (FR) settled between foes then a bit off the rail leaving the backstretch and on the turn and could not offer the needed late kick. FOREST GROVE had good early speed and angled in, dueled inside, fought back on the turn but weakened in the stretch. ENDER'S SHADOW allowed to settle outside then four wide leaving the backstretch, angled to the inside leaving the turn and was not a threat. SAINT BUDDY had good early speed and stalked inside, dropped back into the stretch and weakened. ROI CHARMANT bobbed at the start and unseated the rider. The stewards conducted an inquiry into the start before determining that ROI CHARMANT was the cause of his own trouble.
