Footnotes

SHANE DANIEL broke in onto foes, had speed outside then dueled four wide, continued three deep into the turn, kicked clear and angled in on the bend, opened up in the stretch and held under urging. MELO LASER bumped at the start, dueled between horses then stalked alongside a rival on the turn and held second. BROTHER ERNIE dueled between horses then steadied when shuffled back into the turn, continued outside a rival, came three deep into the stretch and went willingly to the wire. TEMPTING SOLUTION pulled his way along inside and steadied slightly off heels into the turn, came out on the bend and four wide into the stretch and improved position. ONEBADBOY bumped between horses at the start, was sent between foes then stalked outside a rival, angled in on the turn, came out three deep into the stretch and lacked the needed rally. SEANY'S COURAGE stalked inside, was in a bit tight off heels into the turn, came out some in the lane and could not offer the necessary response. HUEGA bumped at the start, was sent between horses then dueled inside, stalked along the rail on the turn and weakened in the stretch. IRONICALLY bobbled slightly then was bumped between foes at the start, had speed

between rivals then stalked outside, went three deep on the turn and into the stretch and also weakened. ANOTHER BERTRANDO broke out and a bit in the air and bumped a rival then was steadied at the start, settled off the rail then outside a foe, split horses leaving the turn and was not a threat. A claim of foul by the rider of BROTHER ERNIE against the runner-up for alleged interference into the turn was not allowed by the stewards, who ruled the videotape failed to substantiate the claim.
