Footnotes

FOUL PLAY a bit slow to begin, went up inside to duel for the lead, inched away past the eighth pole and held gamely under urging. BROOKER broke a bit slowly, settled off the rail then outside on the turn and four wide into the stretch and finished well. PRESIDENTIAL CAUSE unhurried a bit off the rail on the backstretch and turn, swung three deep into the stretch and had a late bid outside. COUNT ORANGE stalked four wide, bid three deep on the turn and in the stretch and lost third late. COMMON TRUST had speed outside then dueled alongside the winner and between horses on the turn and to midstretch, then weakened. MIKE'S TRIPPIN chased between horses, came three deep into the stretch and lacked a further response. JOHNNY HIGH BRITE stalked between rivals, was in a bit tight midway on the backstretch, continued between foes into and on the turn and weakened. INDIAN WEAVER hopped slightly in a slow start, went up inside to chase the pace and lacked a response in the stretch. BROTHER MAN chased between foes then off the rail on the backstretch, went four wide on the turn and into the stretch and had little left.
