Footnotes

SPICY GIRL (FR) broke slowly, saved ground off the pace, split rivals into and leaving the second turn, bid three deep into the stretch, surged to the front past midstretch and proved best under steady handling. CORACLE angled in early and stalked the pace a bit off the rail, bid outside the pacesetter on the second tun, gained a short lead nearing midstretch, battled between foes just past the eighth pole, could not match the winner but bested the rest. MICHIGAN BLUFF saved ground chasing the pace to the stretch, came out some in midstretch and gained the show late. MISS PIXIE sped to the early lead and angled in, set the pace along the inside, battled inside the runner-up on the second turn and until past midstretch and weakened late. GILBOA (FR) saved ground off the pace, moved up leaving the second turn, came out into the stretch and offered a mild bid. COOKIN VICKIE brushed the side of the gate at the start, chased outside a rival early, went three deep on the second turn, dropped back and weakened. CHIME AFTER CHIME pulled hard and came off the rail under a hold on the first turn, stalked the pace outside a rival, fell back some on the second turn, came wide into the stretch and also weakened.
