WESTERLY MAGIC stalked outside a rival, came three deep into the stretch, gained the lead under strong handling nearing midstretch, drifted in some and won clear. ROMP (ARG) settled outside a rival then a bit off the rail, came out in the stretch and finished well for the place. MISSISSIPPIAN (IRE) saved ground chasing the pace, came out leaving the second turn and into the stretch and bested the others. DADSALITTLEUNUSUAL chased inside, awaited room leaving the second turn and to midstretch, got through along the rail and lacked the needed late kick. SOUTH COAST took the early lead outside rivals then angled in, set the pace inside, dueled on the second turn and into the stretch, fought back inside the winner in midstretch, then weakened. BRIGHT PREDICTION stalked a bit off the rail, bid outside the pacesetter into and on the second turn, was between horses into the stretch and weakened in the final furlong.
