FOR TWO-YEAR-OLDS. By subscription of \$150 each, on or before Thursday, October 28. Closed with 15. Or by supplementary nomination of \$2,000 each by closing time of entries. Closed with 1. \$500 to pass the entry box and an additional \$1,000 to start, with \$60,000 to the winner, \$20,000 to second, \$12,000 to third, \$6,000 to fourth and \$2,000 to fifth. 123 lbs. Non-winners of a stake of \$60,000 at a mile or over allowed 2 lbs.; such a race at any distance, 4lbs.; non-winners of a race other than maiden, claiming or starter, 6 lbs.; of a race other than claiming or starter, 8 lbs. Starters to be named through the entry box by closing time of entries. Total earnings in 2010 will be used in determining the order of preference of horses assigned equal weights. All fees for entrants that fail to draw into this race will be cancelled. A trophy will be presented to the owner of the winner. No fees for any horses which made the Friday, July 9 sustaining payment to the CashCall Futurity. (Does not include supplementary nominations).

COMMA TO THE TOP sped to the early lead and angled in, set a pressured pace inside, inched away into the second turn, drew off in the stretch and won clear under some late urging and steady handling. PRAYER FOR RELIEF saved ground chasing the pace, moved up inside leaving the second turn and into the stretch, came a bit off the rail in the drive and was clearly second best. CLEARANCE CLARENCE four wide into the first turn, chased outside then alongside a rival, went three deep leaving the second turn and into the stretch and picked up the show. DIVINE CHILD wide early, angled in and raced unhurried off the rail, swung four wide into the stretch and improved position. JAKESAM pulled between foes early then stalked off the rail, dropped back between rivals leaving the second turn and weakened. CELESTIC NIGHT chased inside, came off the rail on the second turn and moved up to stalk the winner but weakened in the drive. WEALTHY AVIATOR broke a bit slowly and was squeezed, settled just off the rail then outside a rival on the backstretch and most of the second turn and did not rally. DIME broke out a bit, angled in and prompted the pace outside the winner, stalked into the second turn, dropped back past midway on that turn, came three deep into the stretch and had little left for the drive.
