LUCKY J. H. had good early speed and dueled three deep, regained a short lead on the turn, ducked in midstretch, was straightened and gamely prevailed. UNCLE DENNY hopped a bit at the start, went up inside to duel for command, put a head in front into the turn, fought back on the bend, steadied when crowded in midstretch and continued willingly to the end. MATT'S MEMO dueled between horses, was in a bit tight in midstretch and weakened but bested the others. NICKEL SILVER saved ground off the pace, came outside a rival into the stretch and failed to menace. SLIDE HOME had speed three deep between foes then stalked off the rail, angled in and dropped back on the turn and gave way. Following a stewards' inquiry, LUCKY J.H. was disqualified and placed second for interference in midstretch.
