### Footnotes

RIVER VALLEY LASS reserved outside a rival then off the rail, split horses with a forward move leaving the turn, bid three deep in midstretch, gained the lead and pulled clear under an energetic hand ride. HIGH BOLLY dueled outside a rival, inched away and angled in leaving the backstretch, battled inside leaving the second turn and in the stretch, was no match for the winner but held second. THUNDER SERENADE saved ground, moved up inside leaving the backstretch, bid three deep on the second turn and into the stretch and edged a rival late for the show. HIGH AND RISING saved ground stalking the pace, bid outside the runner-up and dueled on the second turn and into the stretch, put a head in front nearing midstretch, then weakened some and lost third late. DEMON IN THE ROUGH had good early speed and angled in on a short advantage on the first turn, dueled inside, dropped back nearing the second turn and weakened. BELLA VOLARE pulled her way along outside a rival then a bit off the rail, drifted out while being pulled up approaching the second turn but walked off.
