

TURBULENT DESCENT went up to press the pace three deep between horses to the stretch, took the lead in upper stretch, inched away while drifting in past midstretch and proved best in hand. ZAZU stalked outside early, prompted the pace four wide to the stretch, battled outside the winner in midstretch, also drifted in and was clearly second best. TALES IN EXCESS sped to the early lead, angled in and dueled inside, fought back into the stretch and weakened but held third. WARREN'S FLYER settled inside then outside a rival on the backstretch and into the turn, continued a bit off the rail on the turn, came out some in the stretch and was edged for the show. SUGARINTHEMORNING broke in slightly and was a bit slow into stride, went up between horses to duel for the lead and weakened in the stretch. RECIPIENT pulled a bit and chased inside, dropped back into and on the turn, came out into the stretch and gave way.
