Footnotes

ANZIYAN ROYALTY chased inside then off the rail, bid three deep on the second turn, came in a bit nearing midway on the bend, took command and angled in leaving the turn, and held on gamely under left handed urging. SHARPSTER chased three deep then off the rail on the backstretch, angled in and bid inside but steadied along the rail in tight midway on the second turn, came out into the stretch and continued willingly but could not catch the winner. SOMBRIO between horses early, angled in and dueled inside a foe but a bit off the rail, steadied in tight between rivals midway on the second turn and just held third. FLYING GENERAL unhurried inside then a bit off the rail, moved up outside on the second turn, split horses into the stretch and just missed the show. MUSIQUE TOUJOURS chased four wide on the first turn and backstretch, angled in approaching the second turn, found the rail in the drive and weakened. INTEGRAL chased between horses on the first turn and backstretch, angled to the inside on the second turn and also weakened. BLAIRS GENERAL saved ground off the pace, came out leaving the second turn and gave way. WILDLY EXCESSIVE had speed three deep then dueled outside a rival, was between horses into the second turn, dropped back on that bend, came three wide into the stretch and also gave way. The stewards conducted an inquiry into the incident on the second turn but made no change when they ruled the videotape failed to substantiate that SHARPSTER ever had enough room to get through.
