Footnotes

EXCESS SUMMER bumped at the start, went up between horses then dueled a bit off the rail, kicked clear into the stretch, found the inside and proved best under some urging and a strong hand ride. GREEN TEAM stalked inside then a bit off the rail, was between horses on the turn and into the stretch, could not catch the winner but was game for second. KEDINGTON squeezed back at the start, chased between foes, was in tight leaving the backstretch, angled in for the turn, moved up inside and continued willingly along the rail for third. SPINELESSJELLYFISH chased outside, moved up between horses leaving the backstretch, continued outside on the turn and four wide into the stretch and put in a late bid at a minor award. HOT MARKET forced the pace three deep then outside the winner on the turn, fell back some into the stretch and weakened. GREY MEMO bumped at the start, was unhurried a bit off the rail, came out on the turn and five wide into the stretch and improved position. RIDE AND SHINE chased outside on the backstretch and five wide on the turn and into the stretch and lacked the needed response. CALKINS ROAD also chased outside on the backstretch and turn, came four wide into the stretch and did not rally. COMMERCANT VIC chased off the rail then between horses, went four wide into the turn, steadied off heels into the stretch and weakened. TRAPPER settled a bit off the rail then chased between foes, steadied in tight nearing midway on the turn and weakened. COCONUT MANGO dueled between horses on the backstretch and into the turn, dropped back between foes on the bend and gave way.
