UNA MAS CERVEZA tracked the pace early while four wide, angled into the three path in the turn then took over command in the stretch and drew clear late under a steady drive. ARTICLE stumbled at the start, fanned into the seven path in the turn then rallied in the stretch and was up for place late. HEBE'S PRIDE chased the pace early, angled into the three path in the turn with a mild gain in the stretch run. SOLO GLITTERS pressed the pace early while three wide, angled off the rail into the turn then made a bid in the stretch but hung in the final stages. HELL SPIKE angled into the four path in the turn and improved position. WIN RICH AFFAIR set the pace early from the inside, stayed on the rail into the turn and gave way in the stretch drive. HENAN swung into the six path in the turn while no threat. NO CEASEFIRE steadied through the turn while in the four path inside the quarter pole. WYATTS ME was through after a half. GOOB had brief speed then retreated.
