SCONNIE set the pace early, angled off the rail into the turn then drew away late in the stretch while being ridden out to the finish. BULL MARKET LADY stalked the pace early, angled into the three path in the turn while no match for the winner in the stretch run. SEATTLE DUCHESS was bumped at the start, chased the pace early, angled into the three path in the turn and weakened late in the stretch. CRU CLASS was well placed early, angled into the four path in the turn and moved up in the stretch drive. SHARP FINNISH angled into the five path in the turn while no threat. SHE BE SMOKIN tracked the pace early from the inside, stayed on the rail into the turn and faded late. AUSPICIOUSARGUMENT had early speed then retreated. INDELIBLE showed little. SISSY'S A RUNNER was never involved. PRETTY GAL TOO was done early. AFTER A RIDERS OBJECTION BULL MARKET LADY WAS DISQUALIFIED AND PLACED THIRD FOR INTERFERENCE IN THE BACKSTRETCH AGAINST THE RIDER OF SEATTLE DUCHESS.
