Footnotes

CASCABELLA stalked the pace three wide, bid three wide near the five-sixteenths marker, drove clear leaving the three-sixteenths pole, drifted out while continuing on her left lead and held sway under a steady drive. TWICE THE LADY settled off the pace along the rail around the first turn, inched closer down the backstretch, continued to gain while hugging the rail around the far turn, swung four wide turning for home, rallied through the lane, angled in near the sixteenth pole and was clearly second best. MAJESTIC TIGER was four wide around the first turn, raced three wide around the far turn and finished willingly to gain the show. TRUE BLISS pressed the pace two wide, bid between rivals near the five-sixteenths marker and weakened in the stretch. ON MY WAY was rank while racing between foes early, raced four wide around the far turn and lacked the needed rally. DERBYDAYGIRL set the pace along the rail and gave way in upper stretch. SHE CAN FLY failed to menace while racing two wide. SUPERSTARDOM never factored while racing five wide throughout. QUIET BY SEVEN flashed brief speed inside. BIT OF HEAVEN trailed while kept very wide.
