NO MORE BETS pressed the pace early, angled off the rail into the turn then took over command in the stretch and drew clear late under a steady drive. JAMIN JUSTICE tracked the pace early, angled into the three path in the turn then made a bid in the stretch but flattened out late in the drive. WALLSTREET SPIDER stalked the pace early, while on the inside into the turn and weakened late in the stretch run. MOONRUNNER chased the pace early, angled into the three path in the turn and lacked a late bid in the stretch. REFLECT THE LIGHT angled into the four path in the turn while no threat. WHITE ON WHITE set the pace early, while on the inside into the turn and gave way in the stretch. SNOWY RIDE was done early. ZEALOUSLY was getting out through the turn. SOFIE'S SISTER showed little.
