### Footnotes

MUNICIPAL FINANCE tracked the pace early, angled off the rail into the far turn then took over command in the stretch and cleared the field late. OPILINKO stalked the pace early, angled off the rail into the far turn then drifted out in the stretch while making a bid but hung in the final stages. EBEN ALSAFA was well placed early, angled into the three path in the far turn and moved up in the stretch drive. FLORIDA BLACK TIE chased the pace early, angled into the three path in the far turn and weakened late in the stretch run. SCHECTER set the pace early, while on the inside into the far turn and gave way in the stretch. HE'S OUTA BOUNDS was never a threat. MORMON METEOR showed little. MY TEN DOLLARS was done early.
