Non-winners Of \$21,000 At A Mile Or Over Since June 21 Allowed 2 lbs. \$18,000 at a mile or over since May 21 Allowed 4 lbs. (Races Where Entered For \$25,000 Or Less Not Considered In Allowances). Pursuant to IHRC Rule 71 IAC 7.5-3-4 subsection 1, in races prior to September 1 all three year olds entered to run against older horses, where the weight allowances and step allowances from the claiming price result in a weight of less than 116 lbs. the weight to be carried will be adjusted to 116 lbs. Likewise, for older horses where the weight allowances and step allowances from the claiming price result in a weight less than 118 lbs. the weight to be carried will be adjusted to 118 lbs. Allowances due from apprentices, sex and Indiana Breds will be deducted after the weights have been adjusted in accordance with the aforementioned. (NW1 X)

AGENT DI NOZZO was unhurried early, angled into the three path in the far turn then took over command in the stretch and cleared the field late. PRINCE OF TIME dueled early, angled off the rail into the far turn then drifted out around the eighth pole and yielded late. SKY ALERT was well placed early, angled off the rail into the far turn then made a bid in the stretch but steadied around the eighth pole and altered course. PATRIOTIC DREAM stalked the pace early, angled into the three path in the far turn then made a bid in the stretch but hung late. CLASSY COVE dueled early, while on the inside into the far turn and faltered late in the stretch drive. POWERPOINTER was bumped at the start, angled into the three path in the far turn. DISCUSSION CLOSED chased the pace early, angled into the four path in the far turn and faded late. DRIVEN FORCE was done early.
