PRINCESS PULL was well placed early, angled off the rail into the turn, edged clear late from the rail while drifting out slightly near the wire. FLATTERWITHGLITTER set the pace early, while on the inside into the turn, drew clear stretch but yielded late and held place late. NINA NINA was unhurried early while on the inside into the turn, rallied in the stretch from the inside but did not have enough late. DYE AND DENY was back early, angled into the four path in the turn with a mild gain in the stretch run. MONTALCINO angled into the three path in the turn with some gain in the stretch drive. ECLIPSE MEMORIES chased the pace early, angled into the three path in the turn and weakened late. DIP N DOTTY broke awkward from the gate, pressed the pace early, angled off the rail into the turn and faded late. THE RIDER OF NINA NINA CLAIMED AN OBJECTION AGAINST THE RIDER OF PRINCESS PULL FOR INTERFERENCE IN THE LATE STRETCH BUT IT WAS DISALLOWED.
