MAGNIFICENT WRECK set the pace early, angled off the rail into the far turn then drew clear in the stretch and held in the final stages. FUTURE LAWYER chased the pace early, angled off the rail into the far turn then made a bid in the stretch but did not have enough late. SUGAR'S T BONE was unhurried early, angled off the rail into the far turn then made a bid in the stretch but flattened out late. OPILINKO stalked the pace early, while on the inside into the far turn and weakened late in the stretch drive. EBEN ALSAFA was well placed early, angled into the five path in the far turn and lacked a bid in the stretch run. ROJO CIELO tracked the pace early, angled into the four path in the far turn and faded late in the stretch. SCHECTER was through after a half. IMPLIED BAZINGA fanned very wide going into the first turn. OMATI showed little. MY TEN DOLLARS fanned very wide into the first turn while rank.
